



## ***Trail Accessibility Guide***

### **Programs and Events**

The MetroParks will make every effort, with two weeks advance notice, to provide reasonable accommodations so that people with disabilities may participate in special events and educational programs.

People with disabilities needing special accommodations for the accessibility of programs should contact the MetroParks at 513.867.5835.

### **Trails**

The MetroParks provides the opportunity for individuals with mobility disabilities to use their power-driven mobility devices on select trails. Please refer to the Trail Accessibility Guide below.

The Trail Accessibility Guide and Other Power-Driven Mobility Devices (OPDMD) policy will be available on the MetroParks of Butler County website, and also available for explanation by staff answering the phone at the main office. The levels used for accessibility determination are as follows:

- Level 1** Considered fully accessible and meets architectural standards for handicapped accessibility. Level 1 sites include visitor centers, snack bars, restrooms, picnic areas and paved trails.
- Level 2** Usable to some disabled persons but may include inconveniences.
- Level 3** Difficult to use by disabled persons and inaccessible to some disabled persons; assistance will likely be required. These sites include facilities that are located in difficult terrain and often include barriers such as steps.
- Level 4** Undeveloped or minimally developed section of park; inaccessible to most disabled persons.

This Trail Guide includes MetroParks Properties that are open to the public and will be updated as additional areas are developed and opened for public access.

**NOTES:**

1. If OPDMD are permitted on a certain trail, there is no guarantee that the trail will be suitable for such use on a given day. Weather conditions or other factors beyond the control of the MetroParks may affect the suitability of the trail for OPDMD use.
2. Some segments of trails on MetroParks trail maps have a dual designation where the routes of two or more trails share the same corridor. In this situation, the trail with the most permissive requirements applies to that section. For example, if a segment of trail shares a corridor with one trail that permits OPDMD and another that does not, then OPDMD are permitted on that trail segment.

Each of the open MetroParks sites have also been evaluated for accessibility:

**Angst Nature Preserve MetroPark** - level 4

4050 Trenton-Oxford Road, Hamilton, OH 45011

Parking area is gravel. Trails are hilly and include unbridged stream crossings.

**Chrisholm MetroPark – Chrisholm Historic Farmstead** - level 2

2070 Woodsdale Road, Trenton, OH 45067

Terrain is mostly dirt/gravel. There is access to restrooms from parking area. There are slight inclines around the house and barn than can be muddy.

**Chrisholm MetroPark - Woodsdale Regional Park** - level 3

1917 Woodsdale Road, Trenton, OH 45067

Parking area is paved and area surrounding is all dirt/grass mix. Area is often under water for long periods of time.

**Elk Creek MetroPark – Meadow Ridge** - level 2

5101 Circle Parkway, Middletown, OH 45042

Large paved parking area with accessible portable toilet and kiosk. Trails are mostly paved but some sections are crushed gravel. The trails traverse rolling topography and feature some moderate inclines. The paved trails are narrow and the paved surface is broken up in some areas.

**Elk Creek MetroPark – Sebald Park Area** – level 3

5580 Elk Creek Road, Middletown, OH 45042

Large paved parking areas. There is one accessible playground with direct access to paved parking. Other areas are dirt/grass/gravel mix. Shelters often lack paved pathway connections to parking. Restrooms are located away from parking area and may be difficult to reach without assistance. Trails are often muddy due to tree cover preventing them from drying.

**Forest Run MetroPark – Wildlife Preserve Area** - level 2

1810 New London Road, Hamilton, OH 45013

Large paved parking area with paved pathway connections to accessible vault latrines, kiosk, and playground area. Trails have minor inclines but are dirt/grass mix and can change to mud based on weather.

**Forest Run MetroPark - Engle House Area** - level 2

2051 Timberman Road, Hamilton, OH 45013

Parking area is paved/gravel mix. There is access to main office from south parking area that is paved. There is a minor incline from gravel lot parking area.

**Forest Run MetroPark – Timberman Ridge Area** - level 1

1976 Timberman Road, Hamilton, OH 45013

Paved parking with access to paved trail. Accessible portable toilet provided.

**Four Mile Creek MetroPark - Antenen Nature Preserve Area** - level 4

2385 Treiber Road, Hamilton, OH 45011

Parking area is loose stone. Trails are often washed out with large open areas to cross that are steep inclines made of dirt and mud with tree roots often exposed. Use caution along steep edges of trails near water.

**Gilmore MetroPark** - level 3

7950 Gilmore Road, Hamilton, OH 45015

Small parking area is paved with access to park. Trails are often under water for long periods of time.

**Governor Bebb MetroPark** - level 3

1979 Bebb Park Lane, Okeana, OH 45053

Several paved parking areas, including one with access to an accessible vault latrine. The trails feature steep inclines on very rugged terrain that changes often based on weather. Some trails cross creeks that can have high water with steep inclines in and out of them. There are also steps throughout the trails.

**Indian Creek MetroPark - Springfield Road Area** - level 3

6500 Springfield Road, Oxford, OH 45056

Parking area is paved with paved pathway access to playground. Shelter and portable toilet lack paved pathway access. Trails are very rigorous with steep inclines that are often muddy with tree roots exposed. There are also large box stairs that are filled with gravel. Weather changes this area frequently, leaving ruts in the trails.

**Indian Creek MetroPark Oxford-Reily Road Area** - level 3

1899 Oxford-Reily Road, Oxford, OH 45056

Parking area is paved with connections to accessible vault latrine and kiosk. Trails are near water's edge and consist of sand/dirt/gravel mix. Weather often changes the stability of the ground near the water's edge. Those visiting the water's edge should exercise caution.

**Indian Creek MetroPark - Pater Park Area** - level 3

1054 Garner Road, Oxford, OH 45056

Terrain is all grass and loose gravel with steep inclines at the entrance/exit.

**Indian Creek MetroPark Pioneer Church Area** - level 3

3000 Indian Creek Road, Oxford, OH 45056

Parking area is grass. Steep incline to structures on property that changes based on weather.

**Indian Creek MetroPark - Bunker Hill Cemetery Area** - level 2

5351 Reily Millville Road, Oxford, OH 45056

The surface is mostly grass and is generally flat, but often muddy.

**Rentschler Forest MetroPark - Line Hill Mound Area** - level 3

3620 Hamilton Middletown Road, Hamilton, OH 45011

Small paved parking area. There are steep inclines throughout the park that are often muddy with ruts from washouts. All trails are dirt/grass mix.

**Rentschler Forest MetroPark - Timberhill Area** - level 3

3976 Hamilton Middletown Road, Hamilton, OH 45011

Large paved parking area. Access to several buildings is available via gravel or paved path. Trails are dirt, loose rock and leaves. There are several inclines along trails with stairs and tree roots that are exposed.

**Rentschler Forest MetroPark – Reigart Road Area** - level 2

5701 Reigart Road, Hamilton, OH 45011

Paved parking areas with paved pathway access to flush restrooms, some shelters, and the paved Great Miami River Trail. Not all parts of the park are accessible. Some trails have several inclines that are steep and consist of dirt with narrow passages. There are also several steep drop-offs to creek beds of 5 feet or more. There are also steps made with gravel or stone. Due to ongoing erosion, use caution near edge of Great Miami River.

**Voice of America MetroPark** - level 1

7850 VOA Park Drive, West Chester, OH 45069

Lodge area features large paved parking area with paved pathway access to restrooms, bait shop, lake trail, and lodge. Lake path is paved and mostly flat with minor inclines. Athletic Complex area is also mostly flat with a combination of paved and gravel/grass parking, and features paved pathway access to restrooms and concessions. The Athletic Complex area is generally accessible but can become difficult under heavy rain. Wiggly Field Dog Park features mostly gravel parking and access paths, and the area can become very muddy after rain.
